AGENDA:

1.0 MEETING CALLED TO ORDER

The meeting was called to order at 10:12 a.m. by Mr. Hugo Gonzalez, COBEC Belize Co-Chair.

2.0 WELCOME

Mr. Gonzalez welcomed the membership to the summer conference business meeting hosted by Oklahoma State Univeristy.

3.0 SPECIAL PRESENTATION

Dr. Rick Bateman, Chancellor at Bossier Parish Community College, joined the meeting via Zoom to make a donation of a Belize flag which was presented by Mr. Kirk Fontenot.

4.0 ADOPTION OF AGENDA

The agenda was accepted by the membership as tabled.

5.0 CONFIRMATION OF MINUTES OF REGULAR MEETING OF FEBRUARY 3RD, 2023

The minutes of the winter conference business meeting of February 3rd, 2023 were accepted as tabled by the membership on a motion made by Dr. Oliveras and seconded by Dr. Saunders.

6.0 STANDING COMMITTEE REPORTS

6.1 CAFÉ COMMITTEE REPORT

Dr. Hudley gave an overview of the committee's discussion. She highlighted the need for effective strategies for competency-based instruction and assessment, subject-specific methodologies and seminars. Emphasis was made on program reviews for effective faculty evaluations that are evidence-based. Dr. Oliveras called for faculty who might be interested. Dr. Saunders asked for training sessions for counsellors and librarians.

6.2 RESEARCH COMMITTEE REPORT

Dr. Arzu shared that the Committee has reviewed the Committee's strategic plan and asked the membership to take some time to read it. The strategic plan will be posted on the COBEC website. The membership will be asked to approve it at the next conference. The goal is to raise \$50,000 for research.

Other areas raised included:

- A. Ten (10) doctoral students are being mentored by the Research Committee.
- B. Univeristy of Belize (UB) Journal; the membership was asked for volunteers to review manuscripts. Dr. Hickey will send out an email with information on how to volunteer.
- C. Request for thesis to be housed at Belize National Library.
- D. IRB process at UB is now fully implemented.

6.3 STUDY ABROAD COMMITTEE REPORT

Dr. Oliveras asked that concept notes be shared including different models for 2023. She asked the membership not wait until minutes are sent out and to include visas requirements.

6.4 COLLEGE FAIR COMMITTEE REPORT

Mrs. Marin reported that the College Fair will be held in the City of Belmopan on Wednesday, January 31, 2024. Letters will be sent out in August to increase participation. Data will be collected from participating institutions. US institutions were encouraged to sign up early. CAFÉ workshops will be hosted the same day as the College Fair in the City of Belmopan.

7.0 CONSIDERATION FOR EMERITUS MEMBERSHIP

An application for emeritus membership was received on behalf of Mrs. Allison Martin who is retiring from the Bossier Parish Community College. Dr. Hickey expressed his recommendation. Mr. Gonzalez seconded the recommendation. Mr. Magana spoke about Allison's work and the impact of her work in Belize. Mr. Brown expressed his appreciation for all she has done for CJC and COBEC.

Dr. Aird motioned to approve her status as an emeritus member. Dr. Palacio seconded the motion. The membership approved the motion.

Dr. Hickey expressed the members' love for Allison who shared that belonging to this group is the best part of her professional career.

8.0 CONSIDERATION OF APPLICATIONS FOR MEMBERSHIP

No application was received.

9.0 FINANCIAL REPORTS - BELIZE & US TREASURER

Mr. Brown reported that the beginning balance as of January 1st, 2023 was \$10,146.18. He noted that \$4,919.71 was spent on the College Fair. He added that COBEC US granted COBEC Belize \$1,400.00. Unfortunately, the cheque couldn't be deposited due banking issues. Eight (8) members paid their membership dues. The Belize National Library made its first membership dues payment. ATLIB will refund COBEC for some CAFÉ expenses. The ending balance as at June 31st, 2023, was \$6,059.47. Dr. Saunders asked for a copy of the spreadsheet.

Mrs. Young motioned to accept the Belize treasurer's report. Mr. Magana seconded the motion. The membership approved the motion.

No US treasurer's report was made.

10.0 CONSIDERATION FOR MINI GRANTS

No application for mini grant was received.

11.0 CONSIDERATION FOR INDIVIDUAL MEMBERSHIP

No application was received.

12.0 CONSIDERATION FOR US CHAIR

Mr. Gonzalez shared that a call was made for nominations for US Chair. Dr. Wes Hickey was nominated. Dr. Kemppainen motioned to accept Dr. Hickey as the US Chair. Dr. Terrantino seconded the motion. The US membership unanimously approved the motion.

Dr. Hickey shared that it is an honor to serve and that he is looking forward to serving another term. A lot of great work has been completed but there is the need to continue to look for ways to grow.

12.0 ANY OTHER BUSINESS

A. Affiliation with the International Council of Professors of Educational Leadership

Dr. Hickey shared information about the Executive Director of ICPEL and benefits for COBEC to join. Dr. Palacio has been thinking about relevance. How do we attract more disciplines to COBEC. It is important to expand and bring in other disciplines. Dr. Arzu shared the need to present at conferences, so that research is included in the literature. Next year's ICPEL conference will be held in San Antonio, Texas. Graduate students could present their work at the conference.

B. Student membership

Dr. Hickey shared the idea of adding a student membership category. Dr. Aird suggested that a membership committee be formed to draft the roles and responsibilities of members and that those included in the by-laws. Dr. Kemppainen expressed interest in serving on the Committee.

C. Promotion of membership

It was suggested to create a package explaining the benefits of joining COBEC. If the need arises, a virtual meeting can be called with potential new US members. There is the need to do a better job at informing others who what COBEC does – success stories, videos.

D. Increase Registration fee

Dr. Saunders suggested the need to increase the Belize registration fee to \$150.0 US which would allow attendees breakfast and lunch together.

E. Head Stone

Dr. Aird proposed that COBEC Belize adds a head stone where Dr. Misser's ashes are located. Mr. Gonzalez asked Dr. Palacio to request permission by our quarterly meeting so arrangements can be made.
