Mays Seeks To Improve Campus

A junior pre-med majoring in history from Bucks County, Pennsylvania, Jeff Mays is running for the office of SGA president.

"With the proper leadership and support, the SGA can be an integral part of the campus and can improve campus life on or off campus," he says.

A member of Tau Kappa Epsilon, Jeff is a representative to and was secretary of the IFC. "The SGA can improve the social educational life of students

and can alleviate disciplinary problems," he added.

Supporting the idea of overhead crossing facilities on Oak Street, he believes that security or town policeman should be placed on the street to provide safe crossing areas from the parking lot.

Jeff opposes an increase in the student activities fees unless it benefits all students. He also holds that a published account of all monies allocated to and spent by the SGA should be provided.

"The only solution to student evacuation of the campus is more emphasis on weekend activities," he said, "and to encourage and present more weekend events."

"We need to publicize these events more fully in advance," he added.

Jeff, a sophomore and a junior boys' representative, believes that one of the "main things to be done next year is to standardize dorm regulations, making the rules consistent and with similar enforcements." He also believes that female students should have an extra portion of time allowed after curfew.

After the limits is reached, however, the girl would have to attend court every other time she is late.

"The men's dorms," he continued, "should be composed of conscientious students who keep the residence hall quiet and appropriate for study."

"This year," he added, "this attitude has been almost non-existent, and I feel that stricter measures should be taken

against offenders."

"When the residence halls here at VSC become co-ed," he said, "I believe that the men will act more mature and will not pull fire alarms, overturn fire extinguishers, and will require less disciplinary action."

Advocating that a representa-

tive of the Campus Canopy be present at all SGA meetings and publish the activities, Jeff feels that this will encourage more student participation. "If the students know what the Student Government Association is doing, then maybe they will get involved in these activities," he explained.

He also believes that the budgets of all enterprises and fee-supported programs should be published.

Supporting the junior-year-abroad programs at other institutions, Jeff feels that VSC students should be able to go to a European college or university and receive credit for the course they take overseas.

Instead of promising unattainable objectives during his campaign, Jeff states, "I promise that I will look at all suggestions and recommendations from anyone or any organization with an open mind, and that I will present them to the students, SGA, and administration."

Howell Campaigns For Court Revision

A junior from Lakeland and majoring in pre-med, Charlie Howell is one of three students contending for the position of SGA president.

Focusing on the court system, Charlie believes that "the student court system at VSC needs to be greatly revised, because many of the dorms have an ineffective or inefficient court."

"Some of the dorm courts seem to be run by the house directors, and I believe that it should be run by a court member," he continued.

"The residence hall courts are created by the Student Court, and I believe that every dorm court session should be reported to the Student Court," he added.

He further advocates that only SGA rules should be used in the residence halls. If new laws are needed in a dorm, they will then be approved by the SGA and followed in all the residence

halls, creating a uniform code for all dorm courts to follow.

A transfer student from Mackey Junior College, Charlie also holds that "all court members should meet certain qualifications, such as a 2.0 grade average, and should attend a clinic on court procedures and rules before filling the post."

"Concerned students," he added, "should make up the courts, and only concerned students should become justices."

"With a co-educational residence hall," he continued, "discipline problems decrease when a co-ed court rules."

Advising a revision of the Student Code of Ethics, Charlie says, "there are rules affecting only fraternities, and there should be included in a strong Inter-Fraternity Council." Other rules exist that have never been enforced and which are superfluous. A streamlining of the

code needs to be undertaken.

Concerning the student activities fees, Charlie believes that a student referendum should be voted on by the students, allowing the students to determine whether or not the fees be raised."

If the proposal is accepted by the student body, then it would be sent to President S.W. Martin and the Board of Regents for final approval.

"I believe that such organizations as the ACS and other active groups are the answer to student apathy," he stated. "More interest in student activities and organizations will abolish apathy and create stronger organizations."

"This year we will have a larger SGA and will involve more students. College students want more responsibility and more freedom, and the best way to

obtain these is to actively work," he continued.

"Athletic funds should not be cut," Charlie said, "because VSC is known for its basketball and baseball teams. We attract students with our excellent teams and gain publicity for the school."

I want to urge every student to vote," he concluded, "because we need more than 800 out of 2400 students voting in order to have an effective representation."

"If we have a majority of students voting, they will select the candidates the entire school wants."

Familiar with the student government and its problems, he has been secretary of the VSC student government, a justice of the student court, and had

helped former president Bill Pannell to re-write the SGA constitution.

A member of Sigma Phi Epsilon, Charlie belongs to the Black Key.

Gosier Promises New Style Of Leadership

Clarence Gosier, a sophomore majoring in physics, is seeking the office of SGA during his second year at VSC.

Believing that the SGA can become more effective only by communication with students, Clarence states that "students should be informed on reports and policies before decisions are made by the administration and SGA, instead of being told what the decision is."

His platform includes seven main points. A forum open to student opinions should discuss the student activity fee, allowing student opinion to influence how and for what the fee is spent.

Clarence advocates that a SGA

constitutional amendment be added to provide for a popular election of all student court officials under Article, II, Section B2.

"A re-evaluation of curfew and house rules for female students is needed," he says, "to allow co-eds to decide for themselves the policies under which they will live."

"Parking fees need to be reduced, also," he continued, "because students will need to catch a cab in order to get to class."

Clarence plans to present a student appeal to the Board of Regents requesting a retention of the plus system in the grading scale.

"Keeping the student body informed and issues, before policies are determined, will be my main goal," he continued.

A former baseball pitcher for a minor league in Auburn, NY, Clarence believes that "athletes should receive scholarships only if they need it to pay for their education."

"A scholarship should be considered only on need and not just on athletic ability," he concluded.

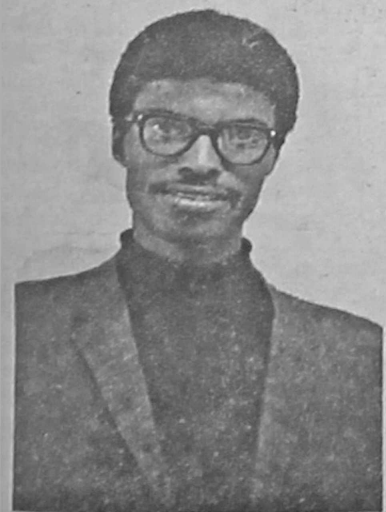
He also holds that personalities and a variety of speakers should be brought to this campus.

Considering a SGA bulletin to

be placed in student postal boxes, he believes that a regular column should be provided in the Campus Canopy for SGA reports.

Platform of Issues

Freeman Emphasizes Student Issues

Howard Freeman, a sophomore history major from Waycross, is seeking the office of vice-president of the SGA.

"The SGA must seek to establish a more open line of communication to the administration in an effort to protect student and minority issues," stated Howard.

He advocates the creation of a student issues publication which would be a bulletin mimeographed and distributed by the SGA concerning a specific pressing issue. The SGA would then conduct forums on the issue and distribute petitions among the students.

The SGA could then take the opinions of the student body of Valdosta State directly to the Board of Regents or state legislature in the form of a petition. This would give our campus a place in local, state, and national issues and bring prominent speakers to our campus.

"In the past, issues have traditionally been vague. I hope, however, to bring the issues directly to the students," said Howard. His main platform is the ISSUES: "Individual Students Seeking United-Responsible Efforts."

Howard feels it is important to return the student government back to the students. "Students must be the final arbiters in those regulations

are purely restricted to student environment and are not in conflict with all or state laws or the basic intent of the college."

He advocates liberalization of attendance regulations, the establishment of a uniform plus-minus grading, student reputation on curriculum and

tenure, and faculty review and evaluation.

The elimination of the campus parking problem is one of Howard's main concerns. "We need to make the campus safe for the pedestrian as he is in the majority," he commented.

Realizing the importance of the office he is seeking, Howard states, "Unlike the president, the vice-president doesn't have to worry about being away from campus so much. He is able to be more progressive and work closer with students in that he is not responsible for the liaison between faculty, administration, and students."

He stressed the importance of a review of the code of ethics, a stronger College Union Board with a cross-section of student representation, a revamping of the IFC and Panhellenic programs

in an effort to create and strengthen the Greek System, and uniform student and house court systems, with the publication of all student rules and regulations.

On problems of student affairs, Howard supports an extension of the hours of the Student Union library, and other campus facilities, abolishment of the dorm depository fee, an investigation into the profits of the Student Union snack bar, bookstore, cafeteria, and a public audit of the SGA expenditures, and a permanent non-profit book exchange program on campus.

He also wants a change in rules concerning Greek Housing (changing of town ordinance), creation of off-campus housing for women, revamping of curfew

regulations, and a dropping of the "force" rules of campus housing.

Howard hopes to see a vast expansion of community services involving the whole campus so that the community will support the "true image of the college."

He wants to see the creation of an office for disadvantaged students which would work closely with the placement office and the college counseling service.

Elimination of the spoils system in SGA, student and house

courts, and IFC is also a very pressing problem.

A student issues research committee comprised of SGA members in conjunction with the College Union Board, and the Campus Canopy is also proposed.

Howard is a member of Delta Chi social fraternity, was secretary of the pledge class, and is currently secretary of the brotherhood.

A member of Sigma Alpha Chi honor society, Howard has been on the dean's list for three of his four quarters of college.

Rivenbark Seeks Student Jobs

Kirk Rivenbark, a sophomore psychology major from Waycross, is seeking the position of vice-president of the Student Government Association.

"I want to stress faculty-student relationships in working together to get more accomplished," said Kirk.

"I also want to stress participation by students in student

government so that the SGA can pass students' thoughts on to the administration," he added.

SGA meetings are open to all interested students, but few students attend meetings. In order to gain more student participation, Kirk wants to publicize the meetings through more posters, bulletins, and direct communication. He feels that students would become more aware of the importance of the SGA if they attend the meetings and participated in the workings of student government.

One of the major tasks Kirk hopes to accomplish is the formation of a committee set up by SGA to work directly with Mrs. Joseph Maddox, the placement officer at VSC.

The committee would be composed of either SGA members or students appointed by the SGA. Its purpose would be to attempt to get more big businesses interested in VSC graduates. The committee would correspond with companies to set up convenient interview dates.

"It would also be the committee's job to visit and correspond with local firms, shops, and factories to provide part-time jobs for VSC students,"

said Kirk.

He wants to present a film during freshmen orientation week showing the opportunities offered by the placement service. The film would also be available for campus organizations.

Although agreeing with the idea of a uniform grading system throughout the university system of Georgia, he recommends the 4.5 system rather than the 4.0. "I want to press for the 4.5 system because I don't understand why a uniform 4.5 system would be any less consistent than the 4.0," Kirk said.

He explained that in such a system, there would be grades of A plus and D plus as well as B plus and C plus.

Kirk also believes in posting teachers, whenever possible, for quarter courses because he feels that it is the students right to know who will teach the course.

He also feels that the SGA should back a working plan for disposing of used books at the beginning of the quarter.

Kirk is a member of Pi Kappa Phi and is secretary of the fraternity. He was sophomore representative to the SGA this year.

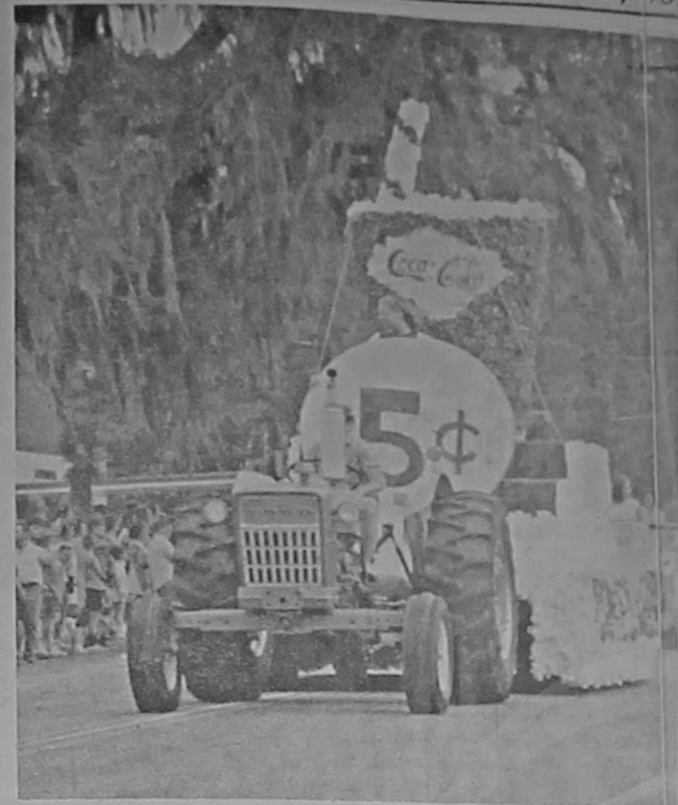
The parade, winding through Lee Hill, Ashley, and Patterson Streets, was composed of floats and bands from Valdosta High and Lowndes county.

The "Bloody Red Baron" was the theme of the Pi Kaps; Alpha Delta Pi remembered when cokes were 5¢, and the Campus Canopy

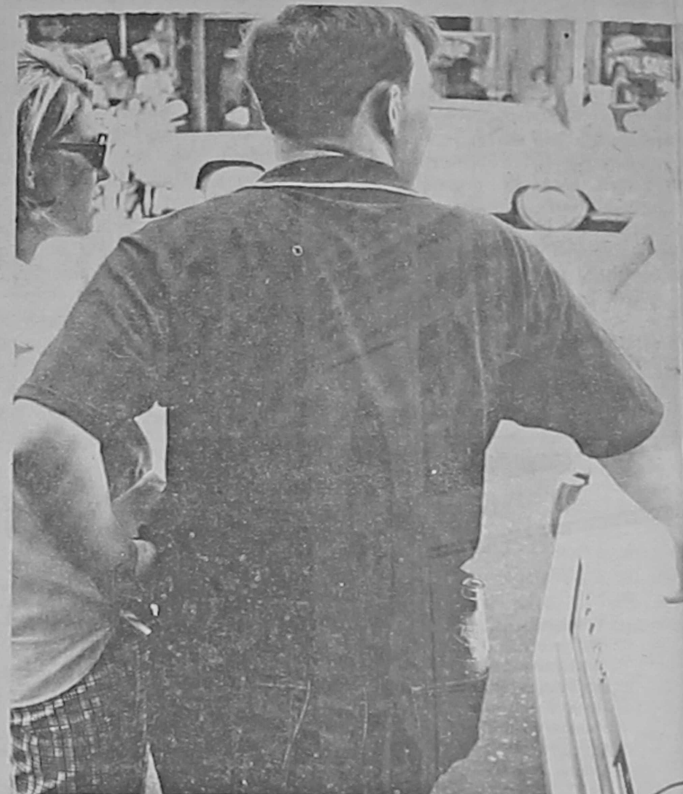

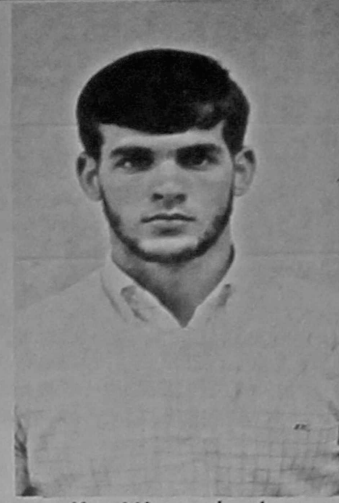

Jim has been vice-president of the Beta Club, vice-president of his junior and senior classes in high school, and brings a lot of energy, initiative, and desire to improve the SGA.

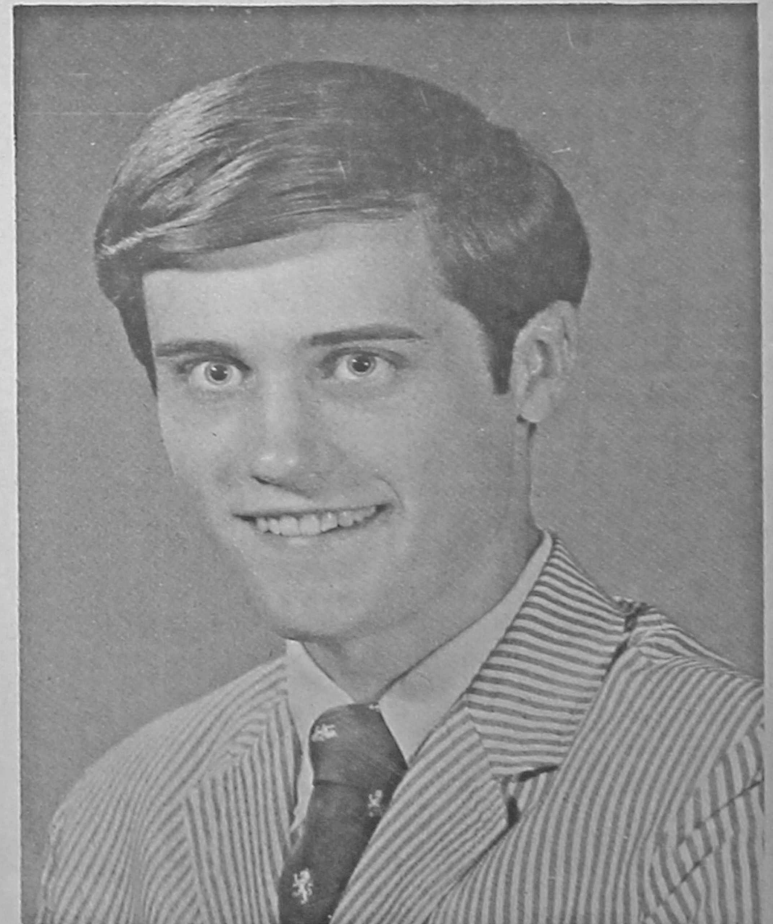
He concluded, "I think I can complement the student body in regards to the president and the vice-president."

Concerning a proposed student activities fees increase, Susan stated that "since athletics are

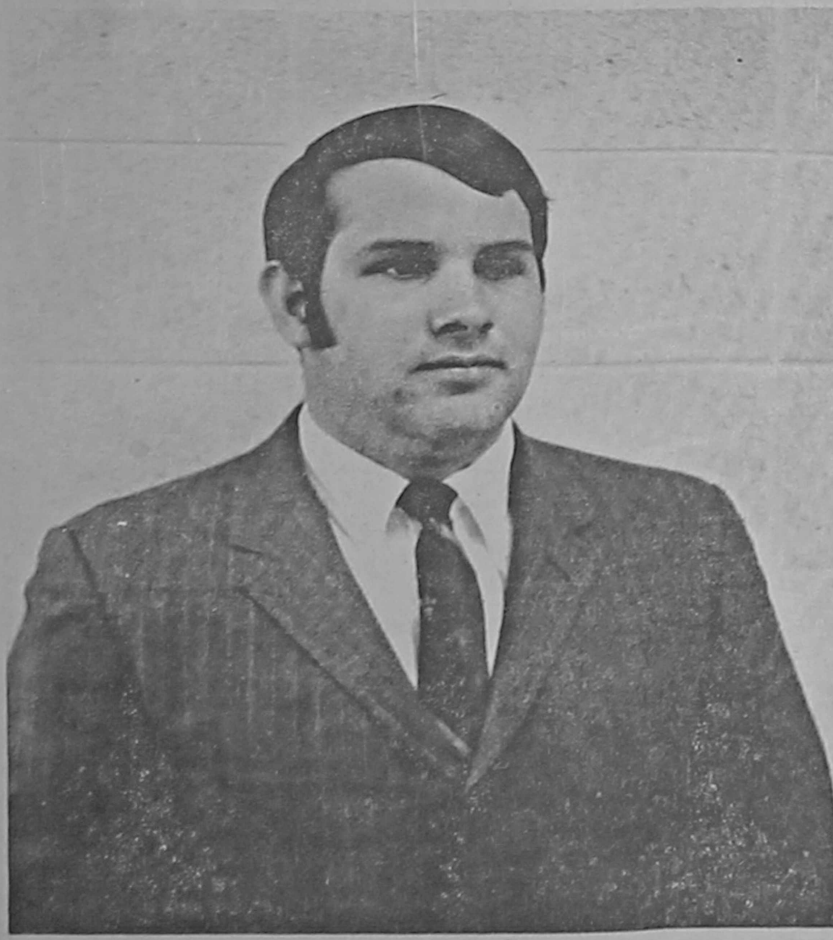
an important part of student interests, the school should be given the means to attract good athletes."

Unfortunately, this type of individual is present and we are forced to tolerate them. My only

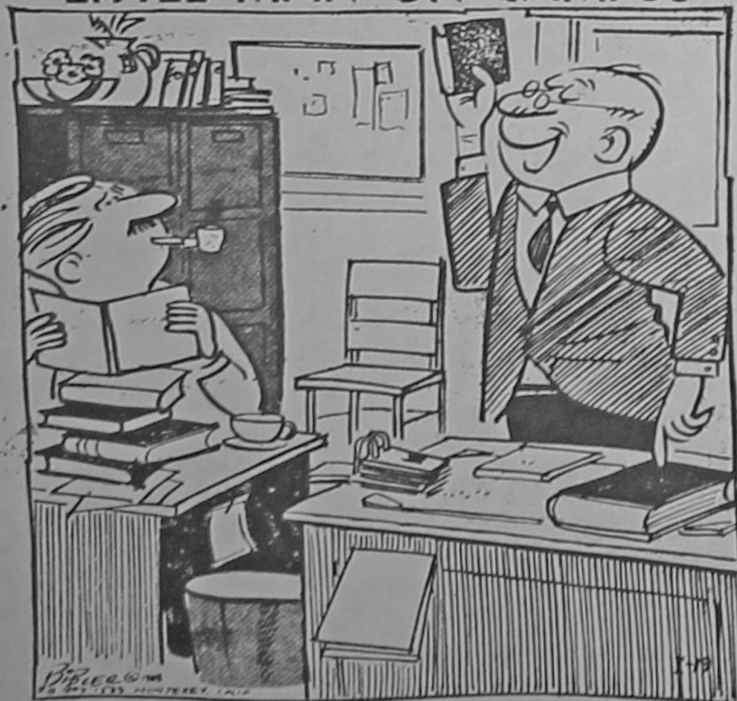
hope is that we need not tolerate them much longer.
