The show will open July 9 and run

3 weekends.

Next season: THE LAST OF THE RED HOT LOVERS, WITNESS FOR THE PROSECU-TION, WIND IN THE WILLOWS, CALL ME MADAM, MY THREE ANGELS, and SAME TIME NEXT YEAR.

The Georgia Council for the Arts' FY'82 appropriation has been increased by \$250,000 to bring the total available for grants to \$1,392,806, or a little over 29¢ per capita.

If yours is a non-profit organization and you want some of that money, the deadline is July 1st. Hurry.



THE AUDITION MATERIAL YOU CHOOSE MAY BE THE KISS OF DEATH!!!

Producers and Directors do get tired of hearing the same thing over and over, you know. Maybe they won't reject you just because they're tired of your selection, but every favorable impression you can make is just one more thing in your favor.

SETC recently took a poll of producers and directors and came up with the following suggestions:

- 1. Choose material that is suitable for your type and age range.
- 2. Avoid choosing material for shock value or cuteness rather than dramatic value.
- 3. Do not use material that requires a stage accent.
- 4. The material should show good, but limited stage movement and allow for good diction and projection.

PRODUCERS/DIRECTORS DO NOT WANT TO HEAR:

Anything from the well-known works of Williams, O'Neill, or Simon, and speeches from The Fantasticks, Equus, The House of Blue Leaves, Bus Stop, The Bell Jar, Kennedy's Children, Why Hanna's Skirt Won't Stay Down, Rosencrantz and Guildenstern Are Dead, Our Town, The Rainmaker, Vanities, Of Mice and Men, Company.

Suggestions concerning musical auditions are equally strong:

- 1. If you can't sing, please don't.
- 2. Choose a song that shows full range of the voice.

3. Sing NOTHING from The Fantasticks, Pippin, Godspell, A Chorus Line, or, indeed, current Broadway Productions.



SAVANNAH GROUP ACQUIRES HISTORIC BUILDING

REMODELING PLANS UNDERWAY

THE LITTLE THEATRE OF SAVANNAH, homeless since March of 1979, has purchased the Savannah Theatre, the oldest continuously operating theatre in the United States.

The Savannah LT has been performing in rented spaces since fire destroyed its former home.

The sale was closed June first. Remodeling will begin almost immediately. The summer musical, SWEET CHARITY, will be staged at the Shriners' Alee Temple Arena, site of the Little Theatre's productions for the last year. Though much work needs to be done to ready the Savannah for LT's use, the season opener, THE MAN WHO CAME TO DINNER, is scheduled for presentation at the Savannah beginning October 2.


The rest of the LT's season is: ANGEL STREET in November (performance available for the GTC Convention) APPLAUSE in February, A STREETCAR NAMED DESIRE in April, and ON GOLDEN POND in May.

Eric DuBois, who just completed BEDROOM FARCE to close the 80-81 season, has been signed to guest-direct next year's opener.

The Little Theatre is continuing to use guest directors until a permanent director can be signed.

Others already inked for the guest spots are Bob R. Patterson, Leslie Gordon, and John Brogna.
